## Privacy Policy

Welcome to gamster.io. Your privacy is important to us, and this Privacy Policy explains how we collect, use, store, and protect your data when you use our website and related Web3 services. By accessing or using gamster.io, you agree to this Privacy Policy.

## 1. Information We Collect

Due to the decentralized nature of Web3, gamster.io may collect limited user data. We collect information that may include:

- **Wallet Addresses:** When connecting a wallet, such as Metamask, we may store your wallet address but not your personal identity.
- **IP Address:** For security and monitoring purposes, we may record your IP address when accessing our services.
- **Usage Data:** We collect analytics data (such as interactions with the site) to improve user experience.
- **Cookies:** Cookies may be used to enhance your experience, especially in Web2 components.

## 2. How We Collect Data

We collect data through:

- **Blockchain Interactions:** Data such as wallet addresses are collected when you interact with our smart contracts.
- **Cookies and Tracking Technologies:** We use cookies for session management and analytics.
- **Direct Communication:** Information you provide when contacting us through support channels.

## 3. Purpose of Data Collection

Your data helps us provide, maintain, and improve gamster.io by:

- Supporting blockchain interactions and transaction history.
- Enhancing security, preventing fraud, and monitoring for compliance.
- Improving user experience through analytics and performance insights.

We prioritize data security and only share information in the following cases:

- **Service Providers:** We may share data with third-party service providers for analytics and security.
- **Compliance with Law:** In case of legal requirements, we may share necessary information with authorities.
- **Business Transfers:** If gamster.io is acquired, user data may be transferred as part of the transaction.

## 5. Data Security

We implement measures to protect your data, including:

- **Encryption:** Sensitive data is encrypted when stored.
- **Smart Contracts Security:** Blockchain interactions are conducted via audited and secure smart contracts.
- **Access Control:** Limited access to data is granted to authorized personnel only.

## 6. User Rights

Your privacy rights include:

- **Access and Correction:** You may request access to your data and update or correct inaccuracies, where possible.
- **Withdrawal of Consent:** You may disconnect your wallet or stop using our services if you wish to limit data collection.

Note: Due to blockchain immutability, some data may not be removable once recorded.
